Victoria Grove Community Service

By law under California Civil Code Section 4580 (B), you as buyer(s) of a property within a community having a transfer fee, have the option to either pay the entire fee, or commit to an installment plan (plus finance and administrative costs) for a period of not less than seven (7) years.

If the entire fee is paid at the time of closing, no finance or administrative charge will apply. Upon selection of the payment in full option, the total fee shall be collected and paid in accordance with the Fee Agreement and applicable law.

If the installment payment plan option is selected, the fee will be billed pursuant to the Fee Agreement at a monthly rate for seven (7) years. The CEF is subject to ten percent (10%) interest and a monthly charge of \$5.00 will be assessed in addition to the set payment amount. Upon selection of the installment option, you shall remit to escrow 1/84th of the total fee along with a \$50.00 set up charge. Upon receipt of confirmation that you have selected the installment plan, a CEF Installment Payment / Amortization Schedule calculating the monthly payment amount based on the total fee and a ten percent (10%) finance cost will be created. This Schedule, along with an installment agreement, will be sent to you to be signed and returned. You should retain the Schedule to determine the amount of your CEF outstanding and owing should you sell your home prior to the expiration of the payment plan.

Enclosed is a CEF Payment Selection Form that must be signed and returned to Victoria Grove Community Service, c/o StoneKastle Community Management, **prior to the close of escrow** for the purchase of your home. If the form is not completed, signed, and received prior to such time, the full amount of the CEF will automatically be collected at the time of closing in accordance with the Fee Agreement and applicable law.
